No detectable respirable titanium dioxide was noted when air sampling studies were conducted on processing ceramic grains containing similar to or greater concentrations of titanium dioxide. Therefore, the health effects associated with titanium dioxide are not expected during the intended use of this product.

#### 7.1 HANDLING
