Eye Contact:

This product contains quartz silica. Cancer of the lungs and silicosis have been associated with quartz (crystalline) silica. No exposure to quartz (crystalline) silica is anticipated during normal intended use of 3M Coated and Surface Conditioning Abrasives. No detectable respirable quartz and other forms of crystalline silica were found when a simulated grinding air sampling study was conducted on analogous 3M Coated Abrasive and Surface Conditioning constructions that contained similar to or greater concentrations of crystalline silica. Therefore, the health effects associated with crystalline silica (e.g. quartz) are not expected during the intended use of this product.

SECTION 7: HANDLING AND STORAGE

7.1 HANDLING

For industrial or professional use only. Avoid breathing of dust created by sanding, grinding or machining. Avoid eye contact with dust or airborne particles. Consider material being abraded when determining the appropriate respiratory protection. Select and use appropriate respirators to prevent inhalation overexposure.
